



Before You Purchase

If you live in a Smoke Control Area (SCA), you must:

- Only use a DEFRA Exempt Appliance or only burn fuels authorised by DEFRA
To find out if you live in an SCA, contact your Local Authority

Newly manufactured appliances placed into the supply chain before the 1st January 2022 are required to meet Ecodesign legislation requirements.

Top Tips

- Use the HETAS product search to easily find **HETAS Cleaner Choice** appliances. These exceed the requirements for Defra Exemption and Ecodesign
- Search for your local **HETAS Approved Retailer** on the website to start your installation journey.

After Your Installation

Your HETAS Registered Installer will run through the correct use of your appliance, including:

- Correctly positioned Carbon Monoxide alarm
- Certificate of Compliance
- Notice plate fitted and location shown
- Manufacturer's instructions
- Commissioning sheet

Contact your appliance manufacturer for your installation warranty.

We encourage:

- Having your chimney swept at least twice a year if burning wood and at least once a year if burning smokeless fuel
- Servicing your appliance at least once a year

Safety Tips

- Keep combustibles, such as wood, at a safe distance from the appliance; never store on the hearth unless stated in manufacturers instructions.
- Keep children and pets away from appliances and flues when in use
- Do not "turn down" the appliance for the night (slumbering) unless the manufacturer has stated the appliance is designed to do so
- Never keep the appliance doors open whilst in use or shortly after use
- Ensure you regularly test your carbon monoxide alarm and replace it before its expiry date
- Select a fuel type matching your appliance's instructions and warranty for a long, reliable and safe service

Ready to Burn

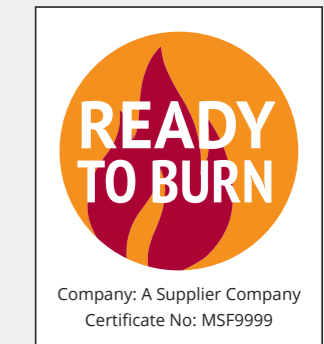
Choose **Ready to Burn** fuels to comply with legislation in England and reduce environmental impact. Look for the certification logo showing the:
